### Payment Schedule

Once you have completed your Tour Application online and submitted it electronically, a non-refundable deposit check for \$200.00 made payable to Edina High School Marching Band and a completed Parental/Guardian Consent Form are due by June 6, 2013. First payment and consent form to be submitted to your band director. Additional payments will be due to Mr. Richter per the above schedule. The money raised by students through fundraising events will be credited directly to their tour accounts.

### Refunds

Due to commitments made to various vendors, **NO REFUNDS** will be possible to any student wishing to cancel their reservation.

### Travel Documents

All participants are required to have a current Edina High School identification card..

### Baggage

Each participant will be allowed one large lightweight suitcase (maximum 26") plus their instrument.

### Release and Contract

I, a participant in the band tour to Branson and The Ozarks, do voluntarily and without reservation and on behalf of myself, my heirs and my estate, waive any and all claims of whatever nature for any injury, loss, damage, accident, delay irregularity or expense arising from the use of any vehicle or services, strikes, war, weather, acts of God, sickness, quarantine, government restrictions or regulations or from any act of omission of any steamship, airline, railroad, bus transportation, sightseeing, hotel or any other service whatsoever in connection therewith against Edina High School Band Boosters (hereinafter referred to as "EBB"), Edina High School, Minnesota Independent School District #273, School Board Members, Andrew Richter (hereinafter referred to as "AR"), chaperons and Simon & Simon Travel including their tour escorts, their heirs and their estates. I authorize AR and EBB or any of its agents, at their discretion, to place me, at my own expense, in a hospital at any point for medical services and treatment, or if no hospital is available to place me in the hands of a local medical doctor for treatment. AR and EBB or its agents are further authorized to place me on a flight home at my own or my parents' expense for medical treatment if this is deemed necessary by them in consultation with local medical authorities.

**As a participant, I promise to support and uphold the standards set forth by Andrew Richter. It is agreed that this is a supervised program and that the group standards must be observed as stated in the following code of conduct:**

- **I agree to maintain the highest standards of public and private conduct realizing that I am an unofficial ambassador of my school while traveling as a part of EBB group tours.**
- **I will agree to follow the supervision of my chaperons during the tour and understand that this being a GROUP tour, I will remain with the group at all times including travel to and from Branson and will participate in all group activities unless AR has deemed my health such that would necessitate my remaining at the hotel with one of the chaperons during a particular group activity.**
- **I will not be allowed to have in my possession or to use alcoholic beverages, cigarettes, cigars, or any illegal drugs including marijuana or hallucinogens.**

**AR reserves the right to terminate the participant's tour for failure to maintain this code of conduct or if he deems his or her acts or conduct detrimental to or incompatible with the interest, harmony, comfort or welfare of the tour as a whole. If an individual participant's tour is terminated, the participant involved will be sent home at his or her expense.**

I agree that AR and EBB reserve the right to make cancellations, changes or substitutions in emergencies or changed conditions.

I am aware that if a major calamity such as earthquake, flood, war or civil disturbance, strike, oil shortage, oil embargo, etc., causes cancellation of the tour, EBB will refund the remainder of all monies remitted by myself which have not been submitted for deposits to vendors. Insofar as reasonably possible, EBB will seek further refunds of those portions remitted for deposit to the vendors (airlines, steamship lines, entrance fees, etc.) to also be refunded to the participant (myself).

I understand that the sole responsibility of EBB to participants is to supply the services as described in their literature, that EBB reserves the right to change any dates, flights, and places that are required which are due to circumstances beyond their control.
